

STJ Acres 2010 Breeding Contract



1. For the purpose of this contract, Steve and/or Tara Jansen of STJ Acres will be referred to as Stallion Owner and _____ of _____ will be referred to as Mare Owner(s).
2. This contract is made by and between the Mare Owner(s) and the Stallion Owner for the purpose of breeding the Mare _____ reg # _____ who is in good health for the purpose of breeding and is owned by the above named Mare Owner(s).
3. Stallion Fees for breeding to the stallion _____ reg # ApHC /ApHCC _____ will be \$ _____ (+ gst) Canadian Dollars. A non-refundable booking fee of \$ 100.00 per mare will be required to reserve the right to breed to the said Stallion in the month of _____ for the breeding season of 2010. The balance of the stallion service fee will be required to be paid in full, prior to mare be removed from STJ Acres property.
4. As with fees per above, when picking the mare up from STJ Acres, a copy of both front and back of the registration papers of the mare(s) being bred are also required to be supplied to STJ Acres. In the event that mare(s) being bred is/are both ApHCC & ApHC registered, copies will be required of both registration certificates.
5. Should, for any natural reason, the Mare be unable to carry a foal to birth, a veterinary certificate will be required and the stallion service fee (less booking fee and mare care of \$5.00(+gst) per day) will be refunded to the Mare Owner.
6. The Mare Owner(s) will take reasonable actions to ensure that the mare carries to full term with a foal that stands and nurses. In the event that the mare does not have a foal that stands and nurses, arrangements will be made with the Stallion Owner for Stallion Service to take place in the next breeding season. Confirmation of such an event will be required to be forwarded to the Stallion Owner by a veterinary service.
7. This contract between the Mare Owner(s) and the Stallion Owner cannot be transferred to any other mare unless agreed upon, in writing, by both the Mare Owner(s) and Stallion Owner.
8. Should for any reason, the Stallion be unable to breed, the full service, including booking fee, will be returned to the Mare Owner(s).

9. This contract will become null and void and fees will be refunded, in the event that the Stallion is unfit for service prior to breeding the mare or in the unlikely event that the Stallion should die.
10. Mare care for 30 days will be included in the cost of the Stallion Service fee. If the mare is required to stay past these 30 days, a mare care fee of \$5.00 per day (+gst) will be assessed for each additional day and will be required to be paid in full, prior to the mare being removed from the premises of STJ Acres.
11. Although the Stallion Owner will do everything possible to prevent any occurrence of injury or death, in the event that the mare, for whatever reason, should require veterinary care, or if the mare should die, the Stallion Owner **WILL NOT BE HELD RESPONSIBLE OR LIABLE UNDER ANY CIRCUMSTANCES.**
12. Should the mare require a farrier, the stallion owner will make every effort to contact the mare owner to schedule a farrier of the mare owners choice. Should the mare owner not be able to be contacted or decline to contact a farrier, the stallion owner will have the right to make alternate arrangements with a farrier of the stallion owners choice. In all cases, arrangements are made at the mare owners cost. This cost will be paid in full, prior to the mare being removed from the premise of STJ Acres.
